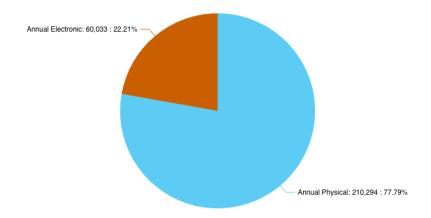

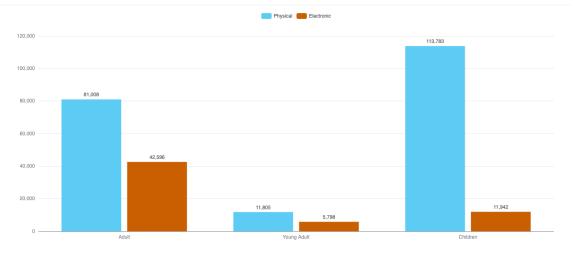

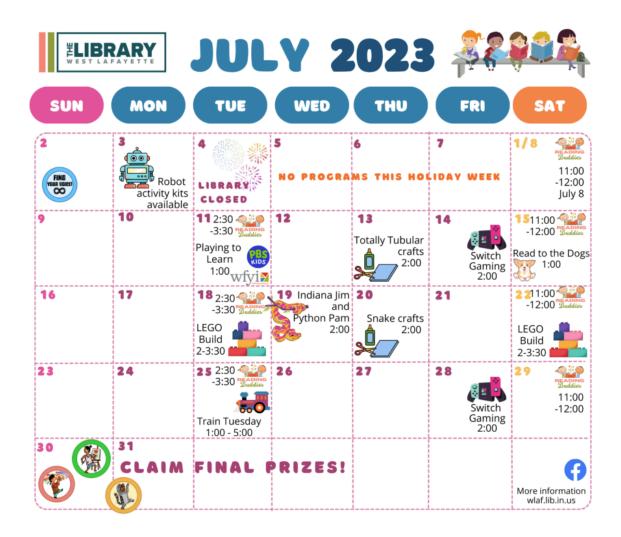

Western Specialty Contractors (WSC), in the performance of the work for Parking Garage Maintenance, have submitted the attached Internal Change Order with Explanation for consideration of the WLPL Board. This Change Order request predominantly provides for a reallocation of funds from the allowance to unforeseen conditions identified in the work. The allowance, as identified within the square footage sum of Item-8 of the Request for Proposal for Surface Repairs, exceeded the actual repairs identified for removal and replacement, which provides a Credit of (\$56,700.00) to the contract.

The unforeseen conditions, including additional joint sealant and additional labor for the proper removal of the deck surface, were identified by the Contractor and viewed on site by Veridus. These conditions, requiring additional labor and materials, having been offset by the credit above total an additional \$37,800.00 to be added to the contract. Having provided quantity pricing within Western Specialties Proposal, these additions were confirmed to be within the level of expectation for unit cost and were improved by a lesser unit cost for Deck and Membrane Joints.

The application of additional unforeseen costs, applied to the available credit, provides for a remaining credit to the contract of (\$19,312.00). This remaining balance is recommended herein to be applied toward addition scope of work for the replacement of (12) steps (stair pans) within the east stair. Having reviewed the site prior to the contract, Veridus, Nick Schenkel, and WSC concur that the conditions are such that replacement be recommended.
